Terms of payment

- A non-refundable retainer fee is to be paid upon signing of this contract.
- This contract becomes valid following receipt of the retainer fee.
- Payment of the total cost is due at least **30 (thirty) days** prior to the wedding. Forms of payment include: personal check, money order or cash.
- In case of cancellation of event, **75%** of total balance will be due regardless of circumstance.
- DVD(s) will be mailed or delivered 6-8 weeks following the wedding to an address specified by client. Photo albums can take up to 8 weeks after the client has approved of the final version
- Please note there is a \$50.00 fee for returned items.

Copyright

- The DVDs of digital files are given to the client for printing additional photographs for personal use in albums or enlargements for personal use only and not for any commercial use.
- The copyright of the images still belong to Jason Holzworth even though the DVD(s) of digital files are in the possession of the client.*
- The client hereby gives Jason Holzworth permission to keep copies of digital photographs to use, publish, resell or advertise any photographs for promotional purposes in albums, publications, or on web pages.
- The client waives any right to inspect or approve that, which may be used in promotions or publication.

Liability

- Jason Holzworth is in no way liable for injuries or damages that may occur in the execution of the contract in relation to equipment used or circumstances beyond the reasonable control of the photographer.
- While every possible precaution is taken and only reputable labs are used, Jason Holzworth assumes no liability for the loss or damage of images held in possession or while at labs or outside sources for services.
- While Jason Holzworth retains copies of the digital files, the client assumes responsibility for maintaining backups for long term archiving of the digital photographs from the original set of DVDs provided to the client.

Cancellation

- In the event of illness, injury and or any unforeseen circumstances that may prevent Jason Holzworth from completing this contract, Jason Holzworth shall immediately advise the Client of the situation and the present agreement will be terminated at no extra cost or charge to the client. Jason Holzworth will provide a comparable replacement photographer and cover any difference in fees charged by that replacement photographer.
- In the event that the client terminates this contract before completion, if the client cancels outside of 180 days the client forfeits their retainer fee.**
- In the event the client terminates this contract before completion, if the client cancels inside of 180 days the client agrees to pay to Jason Holzworth liquidated damages equivalent to 75% of the agreed upon contract price.**

The Final Product

- We are more than happy to edit out non-permanent marks and blemishes (i.e. pimples, zits, etc), but editing out things such as sockets, tattoos, fixing make-up mishaps, and any additional "Photoshopping" and editing will be an additional cost at our discretion.

We, the undersigned, fully agree to all terms and conditions stipulated in the contract, and that all personal information is current and correct. Should any times, dates and locations stipulated in this contract change, the client is responsible to contact Jason Holzworth to correct and confirm these changes.
